

## **WARRANTY for BarBeCube, LLC Grilling Tables and Accessories**

BarBeCube is proud to stand behind its quality line of grilling tables and various accessories through offering a Limited One Year Warranty. Each BarBeCube product has been closely inspected by our craftsmen to offer our customers the highest quality products and accessories. From the BarBeCube Team, thank you so much for purchasing your BarBeCube product!

Now, in the unlikely event that you have a Warranty Claim on a BarBeCube Grilling Table, and/or accessory, these are the TERMS AND CONDITIONS OF THE BARBECUBE, LLC LIMITED ONE YEAR WARRANTY:

1. **GRILLING TABLE AND GRILLING TABLE ACCESSORIES:** BarBeCube Grilling Tables and their associated Grilling Table Accessories carry our LIMITED ONE YEAR WARRANTY (the "Warranty"). For the purpose of the Warranty, any grilling table BarBeCube, LLC manufactures for any grill, smoker, or any other outdoor cooker, will be seen as a "Grilling Table" and any kind of add-on shelf or drawer, or any outdoor table, or top designed to compliment the Grilling Table, will be seen as a "Grilling Table Accessory," including any singular or plural form thereof. The Warranty will only apply to the original purchaser and is only valid as long as the purchaser owns the BarBeCube Grilling Table and if applicable, any associated Grilling Table Accessories.
2. **COMPONENTS:** Any metal, plastic, stainless, and/or wood components used to manufacture any BarBeCube Grilling Table, or any Grilling Table Accessory, carries the Warranty. This includes, but is not limited to any wood, screws, bolts, washers, nuts, castors, etc.
3. **CAUTION NOTICE:** Do not place ANY grill, smoker, or other outdoor cooker directly on the surface of the Grilling Table or any other combustible surface, without making use of a fireproof barrier, such as a 2" non-porous concrete block, or a BGE Table Nest. Make sure the grill, smoker, or other outdoor cooker, is placed directly in the center of it's intended cut-out location, providing at least a ¼ inch gap between the smoker and the Grilling Table, as the grill, smoker, or outdoor cooker should not directly touch the sides of the Grilling Table. BarBeCube, LLC EXPRESSLY DISCLAIMS ANY LIABILITY FOR ANY DIRECT, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGE WHICH MAY RESULT. Furthermore, BarBeCube, LLC will VOID THE WARRANTY IF THE SMOKER, GRILL, OR OUTDOOR COOKER IS NOT SAFELY SUPPORTED WITHIN THE TABLE.
4. **DATE OF COVERAGE:** The Warranty begins the moment the purchaser purchases their Grilling Table, and/or Grilling Table Accessory from the Authorized BarBeCube, LLC Dealer, and lasts exactly a year to that date.
5. **WHAT IS NOT COVERED BY THE WARRANTY:** The Warranty does not cover any accidental losses or incidental losses incurred by breakage or any other damage caused by the purchaser. These kinds of damages or losses not covered by the warranty include but is not limited to: improperly supporting the smoker, grill, or outdoor cooker within the table; improper assembly; any purchaser modifications, or alterations; nor does it cover for any kind of negligence. In addition, the Warranty does not cover for any kinds of natural disaster, such as, but not limited to: hurricanes; tornadoes; floods; wind damage; fire; or any other Act of God. Furthermore, the Warranty does not cover for any damages altering the cosmetic appearance of the Grilling Table and/or Grilling Table Accessories, including but not limited to: normal wear and tear, such as any weathering, cracks, or damages to cosmetic appearances; rust; oxidation; fading; discoloration; or blemishes, unless damages result in a loss to structural integrity. The Warranty will not cover any damages that result from failure to follow the directions within the Use, Handling, and Care Manual, including but not limited to: proper storage and care of the Grilling Table and/or Grilling Table Accessories, such as using the appropriate BGE Table Cover for any BGE Smoker; or from improperly supporting the grill, smoker, or outdoor cooker. ANY DAMAGES THAT RESULT FROM ANY OF THESE HIGHLIGHTED CONDITIONS WILL RESULT IN BARBECUBE, LLC VOIDING THE WARRANTY AND WILL PREVENT COVERAGE FOR DAMAGES TO THE GRILLING TABLE AND/OR GRILLING TABLE ACCESSORIES.

6. **COVERAGE UNDER THE WARRANTY:** Any BarBeCube, LLC components that are found to have any kind of defect involving the materials, or workmanship, will be covered at the sole discretion of BarBeCube, LLC, under the terms and conditions highlighted in the Warranty. Only the damaged component and any other affected components will be subject to the claim as is deemed necessary by BarBeCube, LLC. BarBeCube, LLC WILL NOT replace entire Grilling Tables if only a portion of the table is damaged, nor will BarBeCube, LLC replace an entire Grilling Table in the case that an associated Grilling Table Accessory is damaged. The Warranty only applies to damaged components. Any and all claims must be filed using the appropriate measures highlighted by the Warranty Claim Procedure, and will be covered at no cost to the purchaser, in accordance to the Terms and Conditions of the Warranty.
7. **PURCHASING FROM UNAUTHORIZED DEALERS:** Any BarBeCube Grilling Table, and/or Grilling Table Accessory must be purchased from an authorized dealer for the terms and conditions of the Warranty to apply. Purchasing a Grilling Table and/or a Grilling Table Accessory from an unauthorized dealer will result in BARBECUBE, LLC VOIDING THE TERMS OF THE WARRANTY.
8. **ORIGINAL PURCHASER:** For the Warranty to be valid, the original purchaser is the only person who can file a claim. Their name must either be included on the original purchase receipt, or they must be in possession of the original receipt. The Warranty will be VOID if any BarBeCube Grilling Table or Grilling Table Accessory is purchased second hand, or from an unauthorized dealer.
9. **WARRANTY CLAIM PROCEDURE:** A valid proof of purchase in the form of a receipt from an authorized BarBeCube, LLC Dealer will be required to make a warranty claim. In order to make the claim, the original purchaser's name must be included on the receipt OR they must be in possession of the receipt for us to fulfil the claim. A picture of the damage may be required to process the warranty claim. Please do not attempt to mail or ship any damaged components to BarBeCube, LLC or any of our dealers, unless instructed to do so by an Official BarBeCube, LLC representative. 10. **SHIPPING AND DELIVERY:** BarBeCube, LLC is not held liable for any shipping charges, delivery charges, packaging costs, labor costs, VAT, import/export, levied taxes, or any other charge or fee, associated with the fulfilment of any Warranty Claim, unless authorized in writing by an Official BarBeCube Representative.
11. **DELAY OR DEFAULT:** BarBeCube, LLC will not be held liable for any delay or default in fulfillment of any Warranty Claim that occurs as a result of any circumstance beyond the control of BarBeCube, LLC, such as but not limited to, war, government restrictions, natural disasters, transportation delays, or reduced supply of materials.
12. **OBLIGATIONS:** The Obligation of BarBeCube, LLC is to ensure the repair or replacement of any damaged part or component of a BarBeCube Grilling Table or Grilling Table Accessory as is in accordance to the terms and conditions of this Warranty. Such action will constitute as fulfillment of all Warranty obligations. The purchaser's attempt to resolve any breach of this Warranty is limited as is highlighted by the terms and conditions of this agreement.
13. **LIMITATIONS:** This Warranty is non-transferrable. There are no other warranties, either expressed, or implied, except in any case that may be specifically stated within this Warranty, or as may be applicable in accordance to rights granted on a jurisdictional basis. BarBeCube, LLC does not extend the right to any person, representative, or dealer to assume for BarBeCube, LLC any obligation or liability in connection with any Grilling Table, Grilling Table Accessory, or any other BarBeCube, LLC product. This extends to any warranties, whether written, oral, expressed, or implied.

14. **FURTHER LIMITATIONS:** TO THE MAXIMUM EXTENT AS IS PERMITTED BY LAW, ALL STATUTORY, EXPRESSED, AND IMPLIED WARRANTIES, INCLUDING WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE, AND WARRANTIES OF MERCHANTABILITY, SHALL NOT EXTEND BEYOND THIS WARRANTY. LIABILITIES FOR INCIDENTAL, SPECIAL, AND CONSEQUENTIAL DAMAGES, IS EXCLUDED. Some jurisdictions do not permit the exclusion of limitation of incidental or consequential damages; therefor, the above exclusions or limitations may not apply.
15. **SEVERABILITY:** If any provision of this Warranty is deemed to be unenforceable, then that provision will be modified to the minimum extent to make it enforceable, unless the modification is prohibited by law, in which case, that particular provision will be disregarded. If an unenforceable provision is modified or disregarded in accordance to this Section 15 of the Warranty, then the rest of the Warranty will remain in effect as is written.
16. **GOVERNING LAW:** These terms and conditions of this Warranty shall be governed and construed in accordance with the laws of the State of Florida, and within Federal and State Courts located in Manatee County, Florida.
17. **HEADINGS:** The headings within the Warranty are used purely for convenience and will not alter the terms, nor conditions of this Warranty.
